

Accessing

- 1. Select this link, https://prismrbs.wyzed.com/, or copy/paste it to your browser address bar.
 - a. We recommend using Chrome for your browser.
- 2. The site will display, with a field for your **Email Address** and a **Password**.



- 3. Select Forgot?, in the Password field
- 4. Enter the email address, that this email was sent to, and select **Send me the Instructions** button.




5. The following will display in the top right corner of the browser:




6. Once the email is received, use **Reset Your Password** button, in the email, and reset your password.


7. Once you have logged in you will see something like below.



Navigating



1. Selecting the gear in the top right corner displays the below options:





2. Switching to Learner displays the below options:



Note: Staff/Learners will only see Account Settings and Log Out.

3. Selecting the **Menu** in the top left corner displays the below options (on the left for Admin and on the right for Learner).





Note: You will not see notifications until you have learners completing courses, etc.

Below the **Prism|rbs** logo and to the left, will show you logged in as an Administrator or Learner, depending on which mode you are in.




4. To the right you will see 8 Dash Board buttons, if you are logged in as Admin and 5 if you are logged in as a learner:



8. Use **Search for Course or Topics** to search for specific content.



9. Select a course and the course content will display.



- 10. Select the Video/Content from the list.
- 11. Once you select the section, the content will display. It may be just a video, or a document, video, and questions.
- 12. As sections are completed, they will display a green check mark.

Complete Set up of your Account

- 1. Select the gear in the top right corner then select, **Account Settings**.
- 2. From the options on the left, select **Appearance**.
- 3. Change your **Profile Image** by either uploading and image or selecting one of those available.
- 4. From the options on the left, select Privacy and agree to the Wyzed's Privacy Policy.
- 5. Select Dashboard.
- 6. From the **Menu** select **Learners**.
- 7. Review the learners list and verify that all are part of your staff.

Create Learners

To create a learner you will need your Nebraska Book Company account number.

- 1. You may access the screen to create users two ways.
- 2. From the **Menu** select **Learners** or

Select Manage Learners, from Dash Board buttons.

- 3. In the top left corner select, Create a Learner and walk through the steps below:
- 4. Enter **First** and **Last** name.
- 5. Enter Email Address.
- 6. Check or Uncheck Auto generate password based on what you want to do.

Note: We recommend having the new learner reset their password the first time they log in.

- 7. Check Email login instructions to the learner.
- 8. From Add Tags to Learner, select, Select Tags.
- 9. Enter your **NBC Account Number** in the **Search for tags to filter**, and select your **NBC Account Number**, then select **Save**
- 10. Optionally, Browse Courses and select Self-Paced or other sessions to enroll this Learner. You may enroll learners later as well.

11. Review learner setup and scroll to bottom and select Create User.



Enroll Users in Courses

As an Administrator you may enroll yourself and others in training sessions, both self-paced and instructor led.

Note: Instructor led live training involves a fee. The fee is listed in the description of the course.

There are three ways you can enroll a Learner in a course. The first is at the time you are creating the Learner, the other two are below.

Enroll Learners from Manage Learners

Note: Using this method allows you to enroll a learner in more than one course at a time. This is useful if you are enrolling learners in self-paced courses.


1. Select **Learners** from the **Menu** or

Manager Learners from the Dash Board.


2. From the list of **Learners**, select the **Learner** or **Learners** you want to enroll.



3. Select the Action drop down, then select Enrol Selected.




4. The list of courses will display.




5. Scroll through the list or enter part of the course name to search and locate the course or courses.

6. Select the course or courses for the learner.



7. Scroll to the bottom of the list. Leave checked or uncheck, **Email learners...**, then select **Enrol Learners.**



8. In the top right corner the following displays:

Successfully enrolled 1 learners.


Enroll Learners from a Course

Note: Using this method allows you to enroll a learner in only one course at a time. This is useful if you are enrolling learners in live instructor led courses.


- 1. From the **Dash Board**, scroll down and locate the course, or use the search.
- 2. Select the topic. Once it displays select Manage Learners.




3. Select Enrol Learners, or Enrol Existing Learners and a list of your learners will display.



4. Locate and select the learner(s) to enroll, then select the **Action** drop down and select, **Enrol Selected.**



5. The following confirmation dialog box will display. Leave checked or uncheck, Email learners to notify them of their enrolment, then select Enrol Users.



6. In the top right corner the following displays:



Note: Upon logging in to prismrbs.wyzed.com, the learner will see a notification that they have been enrolled in the course or courses.

Reports


There are three reports available but only two reports, at this time, that you may find useful, User Activity and Course completions. Access Reports from the left Menu,



User Activity

This report allows you to see user activity based on three filters: Learner, Join Type, and Tags. For Administrators you will only use Learner.

- 1. Select the left **Menu**, and then **Reports**.
- 2. Select User Activity.






- 3. To view user activity for a single user, enter their name in the **Filter by Learner** field.
- 4. To view user activity for all users, leave **Filter by Learner** blank.
- 5. Select Run Report.
- 6. The report displays below the filters:



Fields include, Learner, Join Date, Join Type, Sign-Up Page, Last Logged In, Total (Courses enrolled in), Completed (Courses), and Incomplete (Courses).

7. You may export the results by selecting **Download a spreadsheet of these learners**.




- 8. The report will create and download to your computer in excel format.
- 9. The downloaded report will include the fields displayed on screen as well as Tags, Email, and Phone Number.

Course Completions Report

This report allows you to see course completions based on four filters: Learner, Tags, Status, and Course. For Administrators you will only use Learner, Status, or Course.

- 1. Select the left **Menu** = , and then **Reports**.
- 2. Select Course Completions.



- 3. To view course completion for a single user, enter their name in the **Filter by Learner** field.
- 4. To view user activity for all users, leave **Filter by Learner** blank.
- 5. To view course completion based on status, select **Complete**, **Yet to Complete**, or **Overdue**.
- 6. To view all statuses leave All Learners checked.
- 7. To view course completions for a particular course, select, Select Courses drop down and search for the course or courses.
- 8. Scroll to the bottom of the course list and select Save Changes.
- 9. You may filter by one or more of the filters.
- 10. Select Run Report.



11. The report displays below the filters:




Fields include, Learner, Tags, Course, Course Progress, Status, Certificate (We are not currently using certificates), Completion Date, Options. Options is only to print the certificate, which we are not using.


12. You may export the results by selecting **Download a spreadsheet of these learners**.




13. The **Download Report** dialog box displays, giving you the option to have an email sent to you when the report is done, or wait.



14. If you select Email me when done, you will receive an email from info@wyzed.com, when the report is ready.



15. If you wait, once the report is complete the Download Report dialog box displays.



- 16. Select Download.
- 17. The downloaded report will include the fields displayed on screen as well as Email, Phone Number, Enrolment Date, Complete Topics (Number of), Incomplete Topics (Number of), and Total Topics (Number of).
